Both events will be held in our new Progress Sports Complex, directly behind the Ste. Genevieve County Community Center. It's the perfect combination to allow the whole family to shop and celebrate the holidays!

Information:

- **Please be aware that due to space limitations, prime spaces will be given to those who turn in their registration first. Special requests will be taken into account but can NOT be guaranteed.**
- **Set Up:** Friday, December 7th from 6:00pm till 9:30pm and Saturday December 8th beginning at 7:30am. Tables and chairs will be set up and each vendor's name will be posted on their designated table(s).
- **Fees:** \$35 for one 8 foot table, or \$55 for two tables. Fees must be mailed in with the registration. Spots will not be reserved without both payment and a completed contract. Phone payments will not be accepted. Due to spacing, we will not be offering the 'one table plus space' option this year.
- Tables and chairs *are* provided.
- **Electricity:** If electricity is requested at the table, we will assign you a location near an outlet. Extension cords are NOT provided and must be brought by the vendor. Subject to availability
- **Extra Items:** Extra items, such as a hanging rack, display board, etc. that requires extra space adjacent to your tables are not allowed due to the nature of our gymnasium floor.
- **Application:** Your spot will not be reserved without both this completed form and payment.
- **Take Down:** Saturday December 8th by 3:30pm
- Please be aware we have the right to limit the number of vendors selling similar products. We will only allow one vendor from each company to secure a spot. If you are a vendor for a popular company (Mary Kay, Thirty-One, etc.,) please contact the fair organizer or check our website (www.sgccc.com) to see if another vendor has reserved a spot from that company.
- As a vendor, you agree to assist in sharing the news of the event with your current/previous clients, on your social media outlets, and among other avenues to reference the show and encourage attendance.
- If contract and payment are received after tables are sold out, payment will be mailed back. Any cancellations after December 2nd will not receive a refund.
- Spaces sell out quick! There are a limited number of spaces of each type.

General Rules:

No Refunds, refunds are only given in the case of an event cancellation due to weather. No crafter/vendor may sell streamer poppers, snaps, silly string, stink bombs or fireworks. No live animals permitted in the building. Direct Sales businesses will be limited to one vendor per company (first come, first served). No crafter/vendor may sell guns, knives or items considered weapons. No disruptive items may be sold. Vendors, including food vendors, are expected to comply with all federal, state and local laws, rules and regulations, and shall have all appropriate licenses, permits and other required documentation. Trash must be removed from your space when you leave. All work and displays must stay within designated spot. No boxes, extra merchandise or debris should be visible. Assigned area must be kept clean throughout the event and be left spotless afterwards. No soliciting to other crafters/vendors, approaching patrons, or distribution of advertising for anything other than what you are selling in your location. Crafters/Vendors are responsible for collecting and remitting all sales tax. Not all spaces are guaranteed electricity. Ste. Genevieve County Community Center reserves the right to cancel a show due to insufficient registration (refunds issued if show is cancelled). Registration is not complete without payment and signed contract. All agencies including: individuals, organizations, businesses, etc. are required to pay standard fees for space regardless of not-for-profit status. Applications will be reviewed by the Ste. Genevieve County Community Center fair organizer on an individual basis. Ste. Genevieve County Community Center reserves the right to limit the number of vendors selling similar products. Not all applications may be accepted. Wholesalers, flea market products, previously worn/used merchandise will not be accepted. The Ste. Genevieve County Community Center staff reserves the right to not accept applications for items or displays made with poor craftsmanship, look unprofessional, have too many of a certain category, or any other reason at the discretion of the fair organizer. To guarantee your space for the shows, crafters/vendors are encouraged to register as early as possible. Regardless of past show participation, we will not hold spaces for any vendor.
